



NEW GLOBE has successfully and safely executed the handling and transportation of Water Treatment & Regeneration System weighing 122 MT from Baroda-India to Havana-Cuba on 7th March.

It took three weeks to complete this project right from pick up and loading of the goods on board vessel. This shipment was loaded with single handling and reduced transit time of 45 days. Combinations of open-top, flat track, 40'ft containers were used to load the shipment. We appreciate NEW GLOBE's sea export Team led by Mr. Pramod Dhamdhare, General Manager, on successful execution of this project.

NEW GLOBE also had the privilege to handle an export shipment of 2 Soilmec Rigs

The Rigs were weighing 50,590 Kg and 38,200 Kg i.e. a total shipment of 88,790 Kg, from Mumbai to Singapore.

The shipment was customs cleared and handed over to the NYC liners on time i.e. 09th January 2013 - but due to the delay in arrival of the vessel to Mumbai port, the cargo was kept in port under supervision till 20th Jan 2013.

Immediately on berthing of the vessel on 20th Jan NEW GLOBE arranged the movement and loaded the cargo into the

vessel under the liners supervision. The same was done in the nick of time, as the vessel was sailing same evening and NEW GLOBE had very little time for movement as this type of cargo required to be self-driven inside the deck of the vessel and proper lashing to be done to avoid any damage to the vehicle.

The rigs were loaded on level 5 of the vessel which has a total of 12 levels to load such odd size cargo.

The exporter was very happy with the handling of the shipment from NEW GLOBE LOGISTIK end.

JET TRANS SPEDITIONS, PANGEA Member from AUSTRIA informs of Air cargo Screening costs.



The European Commission has implemented a new security law for shippers using air cargo out of Europe, effective from April 29. Once the rule takes effect, only companies listed as Known Consignors can designate their air freight as secure.

Firms that don't submit to the new guidelines will see their shipments undergo increased screening.

Screening costs will be applied for Unknown shippers for each shipment or package and kg.

The shippers' organization, nonetheless, is concerned about the rule and what it means for many EU countries. A press release from ESC pointed out that while some larger countries already adhere to the rules, others may do not.

Due this official rules, you're kindly requested to inform all your customers about above mentioned charges. Because in most of all cases consignee must pay the screening charges.


