China to overtake
Europe and
become the
biggest transport
and logistics market in 2016

Transport Intelligence foresees important growth until 2018 that freight forwarders from other countries can also benefit from if they cooperate

A <u>report</u> from Transport Intelligence notes that the global transport and logistics sector will grow by about 6.8% per year until 2018. This is mainly driven by the increasing demand from emerging markets, and regions like Africa, Central America and especially Asia-Pacific are expected to see increased growth by more than 10% per year.



This growth rate will allow Asia-Pacific to overtake Europe as the world's largest transport and logistics market in 2016 with revenues close to 96,000 million US dollars. China is the most relevant player in this region as economic development is provoking a strong demand for consumer goods and perishables that require more efficient transport and logistics services.

"Infrastructures are still deficient in many of these countries, so the potential is huge" says Cathy Roberson, Senior Analyst, Transport Intelligence. In addition, Bloomberg warns that China has a lack of warehouses, rail networks, shipment tracking services, etc. and that this is holding back sectors like e-commerce. That's the reason why Alibaba and other companies are now considering setting up their own distribution companies.


"Independent freight forwarding companies can also take advantage of this business opportunity if they collaborate with agents in these countries," explains Sarah Bidmead, Network Manager of the Pangea Logistics Network. "Entering in a market like China directly is only possible for the big players, although small and medium sized transport and logistics companies can also avail of this opportunity by establishing partnerships with other agents."

Pangea Logistics Network, a global network of independent freight forwarders, handles 1.5 million shipments worldwide every year and has members in the major Chinese cities and ports like Shanghai, Wuhan, Tianjin, Guangzhou and Ningbo. Members of the network can access the tools to explore and develop collaborations with these agents and take advantage of the momentum in transport and logistics in China.

Sarah Bidmead presents an example: "Let's imagine a Pangea agent in Spain learns about an export support authority organising a trade mission to go to a fair in China. This agent can contact another Pangea member in the Chinese city where the event is taking place and prepare a joint offer to include the collection, shipping, assembly and disassembly of the participants' booths. We have already had similar collaborations between members in other countries, like in the case of Atak-Orbit and Blue Freight at the German fair Fruit Logistica 2015."

# Member interview

### Presentation of TLT-STL, Netherlands, overall solution for livestock logistics

TLT-STL, your PANGEA Partner in Netherlands, is an integrator of logistics services in the air and on the land and sea with special focus on airline logistics, automotive logistics and livestock logistics. It is a pleasure to interview Mr. Heath White, CEO of TLT-STL, to learn more about their specialized solutions and high value services for livestock logistics. We also include below some pictures from their shipments trajectory.

What's the trajectory of TLT-STL with livestock logistics?

We carried out some years ago with a charter of deer from USA in Russia. Although we had done many charters before, this one was very special as it was a new animal for us, which was very sensitive and also there were no real health protocols existing, etc.. Due to the nature of the animal and the lack of expected care in the handling, etc., we took over the whole process including the quarantine and handling at the airport (we chose a small hub in Ohio). Through this, we really saw important it was to provide dedication and to cover all the sensitive elements of the logistics line in one hand. The traditional hubs were complex and costly without the right care we felt. This led us to develop our specialised product for livestock.

What services can you carry out for customers as General Operations Agent, GOA?

We directly carry out all required services to cover the whole process from A-Z with our specialist handling team including liaising with all authorities, setting up of quarantine, all transport modes, final delivery, documentation, customs, etc. We can offer the whole chain A-Z or only a part of this.

Which are the critical points in livestock logistics? And how does TLT-STL plan and coordinate the most suitable solutions?

The whole process, from preparation to delivery, requires full attention and supervision, including liaising with all Authorities and vets, provision of licences, crate building, use of specialized equipment, etc. It is essential that the animals have the required care and treatment at all times and our supervision is part of the service offering.

Our staff comes directly out of the livestock sector and have an affinity to animals in a different way that a pure logistician might. We have developed key hubs (e.g. Rickenbacker, LCK) with airport and port authorities. Together we have created a new handling, where all partners including the authorities have built the product and there is no cost disadvantage even at smaller hubs.

Our mission is to find the best transport solutions, considering distance and the hub best suited. At all times the cost is controlled and reduced, TLT-STL aims to give the least expensive solutions and best care.

Which are the current figures and tendencies of the local and global market?

Although consumer demand of meat continues to be impacted by the difficult economical environment in several key markets, overall production in some EU member states (UK, Poland, Netherlands, Germany) is expected to recover. Globally, the recent long term outlook produced by the OECD suggests that global demand for meat will continue to grow by 1.6% annually over the next decade as higher income levels and increasing urbanization in developing regions

boost demand for protein. This will result in additional millions of tonnes moved and consumed in the coming years. Most of this growth will occur in developing countries such as Asia, South America and Africa. At TLT-STL we ensure that customers have specific solutions for their own product and not standard base-line services as livestock logistics requires.

JACANNA Customs & Freight, New Zealand, handled about 50 tn of products by airfreight for FIFA and ADIDAS.

Jacanna customs & Freight, your PANGEA Partner in New Zealand, is a well-known in the automotive industry, but it doesn't just deliver vehicles - it can move almost anything for anyone. And the FIFA Under-20 World Cup 2015 proves the point with the company's logistical expertise being integral to the success of the planet's second-largest men's tournament featuring "the beautiful game".

Jacanna handled about 50 tonnes of products by air freight for FIFA and Adidas, and made deliveries to stadiums and hotels for staff, players and volunteers. "It ranged from suits and sewing machines to kits, drinks bottles, and training and match balls," says Ken Quigley, managing director. "It goes to show we don't just do cars. For instance, we transported everything for the Brazilian and North Korean teams from the Tarmac at Auckland International Airport to their hotel in New Plymouth where they were for group stages. We were also responsible for looking after Ghana, Portugal, Panama and Austria."

The logistics process for the world cup has been a tight ship. When stadiums closed as their involvement in the tournament ended, it was then a case of exporting everything back to countries around the world. "The whole operation involved months of planning," says Quigley. "We needed about 300 cubic metres of space - the equivalent of about 12 20-foot containers - in storage just for FIFA and Adidas."

It was essential to be flexible 24/7 during the tournament, which ran from May 30 to June 20 and involved seven host cities - Whangarei, Auckland, Hamilton, New Plymouth, Wellington, Christchurch and Dunedin. "Our warehousing team did an exceptional job and Blair Cosford, national operations manager for general cargo logistics, was on the ball throughout the whole process."

Jacanna's work included liaising with Customs, for instance, when it came to temporarily importing cargo to minimise duty and GST payable on equipment that needed to go back to source countries when the tournament ended. "As a logistics provider, it has been demanding but if you prepare well as a business everything will go to plan," explains Quigley. "There was no wiggle room with this competition. On hand, there was the draw for the group stages,

which meant everyone knew what country was playing where and when. Then the knock-out stages threw up unknowns. For example, Uzbekistan knocked out Austria, which meant a trip up to Whangarei to pick up the Austrians' gear, so that tied up staff and trucks."

"Jacanna has been great to work with," says Lisa Tyer, transport and travel manager for FIFA's local organising committee (LOC). "Ken and his team have been really accommodating and professional in their processes, and with warehousing, transport and logistic requirements as required by the LOC. With the nature of a world cup - from the pre-tournament phase, group play and knock-out stages up to and including the final - it is important to be proactive, flexible and have a detailed, planned process for each stadium and match scenario, and also to adapt quickly to the environment, weather, results and requirements a tournament brings"

Jacanna assisted with local ground transport in some host cities, Customs clearances and Ministry for Primary Industries advice to our teams as needed, and also with storage and warehousing pre-tournament as equipment, uniforms and freight arrived from around the world.

For football-mad Quigley, some perks came with the work. "It was great working on this project because I'm so passionate about football," he says. "It was exciting meeting teams and stars of the future. It's been brilliant being involved with such a professional organisation as FIFA. It did a great job, right down to ensuring triple-thick cartons were used for the return of items and limiting cargo damage".

Along with the cricket and rugby world cups, this under-20s tournament has been massive for New Zealand.

"Healthtech: the fastest growing export industry in Finland" by CHS Air Logistics/ Airlog Group (Finland)

The exports of the Finnish healthtech industry are growing briskly posting in 2014 a new record of EUR 1.8 billion with a growth rate of 8.3 % on the previous year. This means that the branch accounted for some 50 % of the exports of the Finnish high-tech industries last year.

According to Planmeca Oy's Veli Mäkelä, who is also the chairman of the board of FiHTA (the Finnish Healthtech Association), there has been some annual fluctuation in the exports of the branch, but the long-term growth has been both continuous and markedly stronger than in almost any other industry in Finland. In the period 2009-2014, the annual growth in the healthtech branch was 8.5 %.

Moreover, the access to the documents shall, at any time from any location, be absolutely safe (due to an individual login, password and encrypted connection) to them.

JAS-FBG S.A. in its logistics centre in Warszowice implements the new management system covering delivery and shipment of consignments. The system is connected with extranet, via which suppliers may notify and book the time of unloading. After the notified vehicle has come and been registered, the system shall identify it and start the notified process in the booked time provided with higher priority. The system manages the parking, the sequence of documents processed at loading and unloading, the

sequence of an entry for particular drivers following priorities and time of arrival, and it also assigns particular ramps according to the goods which are brought, or to be forwarded. The system reduces strain on the centre employees from the necessity to make decisions, as the system makes them in a split second and eliminates potential mistakes. As soon as a storeman has finished operations of a given ramp, the next driver will receive SMS including a dock number to which he is to come. Any person concerned is able to track a given vehicle, ramp or goods. On the other hand, time monitoring of operations at any stage ensures elimination of bottlenecks.

New regulation from Ecuadorian Customs / **CGLOGISTICS S.A.**


